#### You asked us:

'Although I am aware that a solicitor wrote to Balderton Parish Council in April 2023, questioning the legality of The Council's actions and its apparent breach of Covenants on Balderton Lake, I don't know what responses The Council made to these serious allegations and I cannot find any reference to them in Council Minutes.

 In the interests of Openness and Accountability, am I allowed to request copies of The Council's responses to the allegations along with the dates that they were discussed?

Also, with regards to the disclosures of interest noted in the Draft Minutes for 28 February 2024,

I note that these minutes just state that 4 Parish Councillors declared an interest in Item 33(b) *Emails regarding covenant on Balderton Lake and angling rights*. However, the minutes are unclear and do not disclose the nature of their interests.

 In the interests of Openness and Transparency, may I ask what the specific nature of their interests are please?

- 7. On February 28<sup>th</sup>, Councillors Jane Buxton, Karen Callingham, Jean Hall and Joys Sellars declared an interest in Item 33(b) *Emails regarding covenant on Balderton Lake and angling rights*. Their interest is that their properties are affected by it.


