My name is (1) I'm the manager of the first team at Holy Trinity Football Club, we obviously play down at Balderton playing field on Sunday mornings.

I would like to put forward a proposal for the council to consider, we obviously play in the Newark Alliance Sunday league and over the years several grounds have been lost and quality of others pitches have gone downhill. I have said for many years now, that the pitches down at Balderton are the best in Newark, so I would like to ask if you would be willing to host the semi-finals of the willie hall trophy at Balderton playing fields. Obviously both games would be played at the same time with a 10.30am kick off, on the 2 larger pitches, on a Sunday morning, I think the league committee would want both pitches roped off on the 2 sides for supporters, but I did mention this to the groundsmen and they seemed to think it could be done. Also, it may be a consideration for you to open the bar and the Village Center as that day is always supported well and I'm sure at half-time and after the game you would take a-lot of money on the bar, also you could consider a barbeque to make money, depending on your volunteers available.

It would be very much appreciated if you could come back to me with your opinions on this, then I could put you in touch with the Newark alliance committee, to discuss it further if there is any charges involved, and also dates, as I think the original date was the 2nd April for these games, but I'm sure that can be agreed between both parties, if the proposal would be a consideration on your part, with the date fast approaching and fixtures need scheduling around these semi-finals, if you could come back to me at your earliest convenience it would be much appreciated.
