## **Balderton Parish Council**

Minutes of the Parish Council meeting held in the Balderton Village Centre on Wednesday July 12<sup>th</sup> 2017 at 7.00 pm.

## 3917 Apologies

Apologies were received from Cllrs Mrs Brooks, Fletcher, Mrs Newstead, Newstead, Page, Scott and Watt, and County Councillors Girling and Wallace.

#### 3918 **Declarations of Interest**

Cllr Walker, as a serving member of Nottinghamshire County Council declared a personal interest to any issue relating to the County Council. Cllrs Mrs Hurst and Walker as serving members of Newark & Sherwood District Council declared a personal interest to any issue relating to the District Council.

## 3919 **Public Participation**

The meeting was closed to take public comments; the parishioners present did not raise any issues and the meeting re-opened.

#### 3920 Minutes

The minutes of the Annual Parish Council meeting held on May 24<sup>th</sup> 2017, having been circulated previously were confirmed as a true record and signed.

#### 3921 Clerk/Chairman's Update

An update of ongoing matters from the minutes of the previous Council meeting and subsequent committee meetings was circulated and noted. Updates circulated prior to each committee meeting had been included with the minutes. The following issues were discussed from the update:

  - **1. Re Minute 0420 Hope House School** Cllr Allen again expressed concerns about the number of parked cars along Bullpit Road which belong to school staff. The problems are exacerbated by the earthworks currently being undertaken in the area by Severn Trent Water; there is mud all over the road and the verges are badly eroded by passing vehicles forced to drive over them to pass the parked vehicles.
  - **2. Re Minute 0421b Shed in Front Garden** Cllr Mrs Hurst advised that the shed has now been removed from the front garden on 60 Warwick Road.
  - **3.** Re Minute 0421f Vehicles for Sale on Public Highway Cllr Rouse expressed his disquiet that the County Council has claimed that enforcement action cannot be taken against the owner(s) of the vehicles advertised for sale and parked on the grass verge near to the A1 roundabout. Cllr Walker undertook to again raise this issue with the authority.

  - **1. Re Minute 2263 Staple Lane/London Road Junction** Cllr Walker undertook to again raise concerns about road safety issues at this junction with the County Council.

County Councillors are currently invited to submit road improvement projects for consideration and this site could be one such project if a solution can be determined.

## 3924 Reports from Representatives

Cllr Mrs Hurst reported that the Cycle Tour of Britain which comes through Newark on September 6<sup>th</sup> 2017 is a major event that will have a significant impact on Newark that day with parking and associated traffic issues. There will be a 3km 'rolling' road closure as it passes through the area.

District Cllr Payne reported that the last meeting of the District Council had taken place at Kelham Hall; all future Council meetings will take place at the authority's new base 'Castle House' on Kelham Road in Newark.

### 3925 Clerk's Additional Information

The following items of correspondence/information have been received and were noted:

- a) An initial enquiry from a resident asking the Council to consider selling him a piece of land at Lakeside. This was referred to the F&GP committee.
- b) Notice that the Bullpit Road level crossing will be closed from 11pm to the following day at 6pm on July  $15^{th}/16^{th}$ ,  $22^{nd}/23^{rd}$  and  $29^{th}/30^{th}$ .
